 25 capacity as the Attorney General of California, shall be permanently enjoined from
 26 enforcing the Reproductive FACT Act, California Health and Safety Code sections
 27 123470-123473.

1 It is further **ORDERED** that this action is dismissed with prejudice;

2 It is further **ORDERED** that Plaintiffs should be and hereby are declared
3 prevailing parties for purposes of 42 U.S.C. § 1988;

4 It is further **ORDERED** that Plaintiffs shall have thirty (30) days from the
5 entry of this Order and Judgment to submit any motion for attorney’s fees and costs
6 pursuant to 42 U.S.C. § 1988; and

7 It is further **ORDERED** that this Court shall retain jurisdiction over this action
8 for purposes of implementing and enforcing the final judgment, and for resolution
9 of Plaintiffs’ motion for attorney’s fees and costs pursuant to 42 U.S.C. §1988.

10 It is so **ORDERED**.
