PLAINTIFF’S APPLICATION FOR CLERK’S ENTRY OF DEFAULT

Plaintiff, CHILD EVANGELISM FELLOWSHIP OF RHODE ISLAND, INC. (“CEF Rhode Island”), pursuant to Rule 55(a), Fed. R. Civ. P., and Local Rule CV 55(a), applies to the Clerk for entry of a default against each Defendant, PROVIDENCE PUBLIC SCHOOL DISTRICT and DR. JAVIER MONTAÑEZ, in his official capacity as Superintendent of Providence Public School District, for failure to plead or otherwise defend. CEF Rhode Island shows the Clerk as follows in support of this application:

1. As shown by the proofs of service filed at Docs. 9 and 10, CEF Rhode Island effected service on each Defendant pursuant to Rule 4, Fed. R. Civ. P., by causing a summons and copy of the complaint for each Defendant to be personally served on Defendants’ designee on March 20, 2023.

2. The deadline for each Defendant to answer or otherwise respond to the complaint was April 10, 2023. According to the docket, neither Defendant has filed any pleading, motion, or other response to the complaint on or before the deadline, and neither Defendant has entered any appearance or otherwise indicated on the record an intent to defend.

the Clerk must enter a default for each Defendant.
